Call for expression of interest to tender for the supply of a set of optics (lenses+mirrors) in the framework of the ERIS project using a negotiated procedure, by previous consultation, within the meaning of article 36, Paragraph 2 of Law by Decree no. 50/2016.

The present announcement is aimed at receiving expression of interest to favor the participation and the consultation of the largest number of Economical Operators within the respect of the principles of no discrimination, treatment parity and transparency and it is not a call to participate to the tender procedure.

1 SUBJECT OF THIS ANNOUNCEMENT

The INAF-Arcetri Astrophysical Observatory intends to entrust, by means of a negotiated procedure by previous agreement, to be awarded following the criterion of the best value for money, the supply of a set of optics (lenses+mirrors) in the framework of the ERIS project, following the preliminary requirement specification reported in Annex 1. A final version of the specification will be available for the negotiated procedure. Comments on preliminary requirements are welcome. Comments will be evaluated and, if acceptable and compatible with project constraints, used to tune the final documentation for the tender following the present request of interest.

In order to participate in the tender, a proven experience in production of lenses, doublets, triplets and mirrors with accuracy class typical of components reported in Annex 1 will be explicitly required.

2 REQUIREMENTS

All the subjects of Article 45 of law by decree no. 50/2016 are allowed to submit their display of interest to the hereby procedure. The subjects interested to participate:

- must not be in the conditions reported in Article 80, Par. 1, 2, 4 and 5 of the Decree Law no 50/2016
- must satisfy the professional qualifications requirements of Article 83, Par. 3 of the Decree Law no 50/2016

3 PROCEDURE AND DEADLINE FOR SUBMISSION OF INTEREST

The economic operators wishing to send their expression of interest to be invited to the negotiated procedure are required to send by 05 January 2018 their declaration in place, according to the Republic Presidency Decree 445/2000, stating the expression of interest and the possession of the above mentioned

The declaration, undersigned by the legal representative and submitted with a copy of a valid identity document of the subscriber or digitally undersigned, may be sent with subject "ERIS.17-007.MI" by means of email at the following address: inafoaarcetri@pcert.postecert.it and CC to riccardi@arcetri.astro.it.

In case the number of received requests will be greater than 10, a numbered list of the names of the economical operators will be made according to receiving order of the expression of interest. This list shall be recorded to the Protocol.

On the day 08 January 2018 in INAF-Osservatorio di Arcetri at 11:00 in public session it shall be proceeded to the draw of 10 numbers each of which shall correspond to the identity of the economical operator to be invited, as recorded in the above mentioned recorded list.

It is specified that the economical operators submitting an expression of interest and wishing to know the identity of the economical operators invited shall have to wait the deadline set for the submissions of the offers.

4 PERSONAL DATA TREATMENT

The personal data shall be collected and treated exclusively in connection to the activities stated by law and according to the institutional purposes of this research institution, according to the Decree Law no. 196/2003.
